CHILD CARE TRANSPORTATION REQUEST FORMS

Currently, the Troy City Schools provides limited transportation to child care centers. Please contact the transportation center at 937-332-6091 to see if your child care provider is approved for bus services. Troy City Schools Transportation Policy states that “if there is room on the bus, which facilitates the school in question, is going in the provider’s area; the transportation will be provided for that student from/to the childcare provider’s area.” Students will be assigned to the closest bus stop to the child care provider. If for any reason this request is denied, **you will be notified by the school building of attendance.** Please check the District’s Website (www.troy.k12.oh.us) at the beginning of the school year for your child’s bussing information.

****A new request must be completed each school year.**

Your request **MUST** be submitted to the Troy Board of Education by June 30, 2023.

Who receives bus transportation service?

Concord Elementary School - All students bussed **except** for Stonebridge Neighborhood, Rosecrest Dr., Sedwick Way, Stonebride Dr., and Meadowpoint Dr. up to Willowcreek Way

Cookson Elementary School - All walkers

Forest Elementary School - All students north of Stonyridge from N. Market Street to Saratoga; Southview Area and special students as assigned

- Michael Court - Miami East
- Todd Lane - Miami East (except 1201 Todd Lane = Troy)

Heywood Elementary School - All streets west of Dorset from McKaig Road to S. Stanfield Road to W. Main Street to S. Lane; W. Main Street between Ridge and I-75; Home Acres; Southwest Troy bordered by S. Ridge Avenue and W. Market Street; Area bound by N. 25A, including Eldean Road to I-75; Riverside & Orchard Drive

Hook Elementary School - Area bound by W. Main Street and Elm Street to Fairground; Kings Chapel area; Carriage Crossing Way Area; Route 41 E. of Washington to I-75 to Farrington Road

Kyle Elementary School - East side of S. County Road 25A from Dyemill Road to Monroe Concord Road including the Boone Hill area
